Right of Way Permit Conditions

- 1) This permit expires six (6) months from the date of issuance
- 2) Any person doing work under this permit is required to conduct the work in accordance with the appropriate standard drawings and specifications on file in the public works office. (Municipal Code Sec. Chapter 25, Article III. Sec 25-72)
- 3) No materials or debris may be stored on the street pavement or blocking any storm ditch unless expressly permitted. (Municipal Code Sec. Chapter 28, Article V. Sec 28-196)
- 4) Where any portion of street must be blocked for the work under this permit, traffic barricades/control/flagging shall be in accord with the Manual on Uniform Traffic Control Devices.
- 5) Where the work involves the removal of any portion of sidewalk within 16' of the corner of an intersection, all the sidewalk to the corner shall be replaced and an ADA compliant ramp constructed. The city will supply a truncated dome plate for the ramp.
- 6) The restoration of the excavation under this permit is the responsibility of the applicant for a period of four years and repaired within 10 days of opening (Municipal Code Sec. Chapter 25, Article III. Sec 25-56).

In the event restoration of the site is not completed 10 days after opening, the city may perform the work and bill the costs to the applicant.

Sanitary sewer service lines shall comply with MO Rev. Statute 319.033 requiring installation of a tracer wire.

All excavation and right of way permits for State Highways (Bus 63, Hwy 63, Hwy 24, Rt EE, Rt M, E. Outer Road, W. Outer Road) shall be obtained from the Missouri department of Transportation.

Other Federal, State, and local permits may be required for the project described in the permit. The applicant is responsible for obtaining those permits required by law for regulation. (i.e. floodplain permit, land disturbance permit, Corp of Engineers 401 permit).

Failure of the applicant and/or his contractor to comply with the conditions and provisions of this permit may result in a citation for a violation of the City of Moberly Municipal Code.
